Subject : Termination of work order dated 21.05.2018 for Topographical and Contour Survey of protected, prohibited and regulated area around centrally protected monuments/ sites under the jurisdiction of Jodhpur Circle.

Sir,

Kindly refer to work order issued to you by this office vide file No. 07/08/Jodh/Survey/Tender/-2017-641 dated 21.05.2018, wherein you were instructed to undertake the work of Topographical and Contour Survey of protected, prohibited and regulated area around centrally protected monuments/ sites under the jurisdiction of Jodhpur Circle, as per scope of work along with terms and conditions agreed by you at the time of tendering. It is to inform you that this office is cancelling the contract executed for under reference tender on ground of unsatisfactory progress in the above cited assignment.

The reasons which lead to termination of work order are as under :

1. A survey team from your company was arrived at Anasagar Baradari, Ajmer on 25.05.18 as mentioned in your movement order No.1 dated 24.05.18, but the survey instruments and accessories they had brought, were not according the procedure as specified in page 7 of tender documents. The Surveyor of this office has personally examined the instruments at Ajmer in accordance of work order and found that the equipments, which were being used by your survey team, were not according to the tender. Even nozzle and bubble level of Prism Pole were found damaged. All these issues were brought in your notice through this office letter dated 29.05.2018 and 06.06.2018 and a copy of report of the Surveyor dated 27.05.18 was also made available to you.
2. A letter dated 11.06.2018 received from your end through which you had ensured this office that calibration certificates issued by authorized service centre will be produced. To provide fair justice, you were directed vide letter dated 14.06.2018 to furnish relevant documents pertaining to accuracy of your survey equipments and proper calibration certificates of Total station instrument and DGPS machine including all other accessories. Till date, no response received from your side in this regard.
3. On 17.07.18, a last warning letter with reference of all previous correspondences was issued and you were instructed to take necessary action on the pending matters, but your reply was not satisfactory.
4. Even after lapse of reasonable time of more than 2 months, no progress has been noticed, while the time period for execution of the work was only 90 days as mentioned in page no. 5 of tender document published vide no. 07/08/Jodh/Survey/Tender/-2017-36 dated 12.02.2018.

The aforesaid facts indicates the non-compliance of the contractual terms on your part and it invites termination of work order dated 21.05.2018.

Hence, work order dated 21.05.2018 (copy enclosed) for preparation of Topographical and Contour Survey of protected, prohibited and regulated area around centrally protected monuments/ sites under the jurisdiction of Jodhpur Circle is hereby terminated with immediate effect. Further, M/s Chadha Project Services, Noida is hereby debarred from participating in any future tender process of this office for a period of three years and the earnest money deposit (EMD) & Fixed deposit receipt (FDR) are also forfeited. No any further correspondence will be entertained at this end.
