

- 11. The bidders shall give a list of Non-Gazetted employees related to him.
- 12. If any bidder withdraws his tender/auction before the said period or make any modifications in the terms and conditions of the tender, will not be accepted by the department. Then the government shall forfeit 100% of the said earnest money absolutely.

- 14. Failure to remit the bid amount. The E.M.D. amount of highest bidder will be forfeit and the expenditure of re-bidding to be borne by the highest bidder.
- 15. The highest bidder should not make any damage to the centrally protected monuments during the lease period failure to the above conditions; action will be taken against the lease violation of AMASR act.
- 16. During the contract period, the fee should be collected for **Two Wheelers Rs. 10/-, Three Wheelers Rs. 20/-, Four Wheelers (Jeep/Car/Taxi/Tractor Trolley/LMV etc.)Rs. 50/-, Mini Bus/Bus/Truck/HMV etc. Rs. 80/-** and a board to the effect should be displayed visibly.
- 17. The licensee cannot enhance/revise the parking rates without prior approval of Superintending Archaeologist Jodhpur Circle/ASI HQ.
- 18. All the Central/State Govt. vehicles on official duties would be entertained free of cost.
- 19. The licensee shall pay 3 months license fee, as refundable performance security deposit to the SA, ASI, Jodhpur, Circle in the form of Bank Guarantee or FD hypothecated to SA, Jodhpur Circle, valid for a period of 24 months from the date of signing of contract. The performance Security deposit shall be furnished within 14 days after issuing intent letter.
- 20. The licensee shall remit the license fee for each half-yearly period in advance by first week of the month through a Demand Draft drawn in favour of the Superintending Archaeologist, Archaeological Survey of India, Jodhpur Circle, payable at any scheduled bank located in Rajasthan.
- 21. In the event of non-payment of the license fee at least fifteen (15) days prior to the expiry of the respective six-month period, a simple interest at the rate of 12% per annum shall be levied on the delayed amount, without prejudice to any other rights or legal remedies available to the Archaeological Survey of India.

The bidders are required to submit soft copies of their bids electronically on the CPP Portal using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

Registration

- 1. Bidders are required to enrol on the e-procurement module of the Central Public Procurement Portal (URL https://eprocure.gov.in/eprocure/app) by clicking on the link "Online Bidder Enrolment" on the CPP Portal which is free of charge.
- 2. As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 3. Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 4. Upon enrolment the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with signing key Usage) issued by any certifying authority recognized by CCA India (e.g. sify/NCode/EMudhra etc.) with their profile.
- 5. Only one valid DSC should be registered by a Bidder, Please note that the Bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.

PREPARATION OF BIDS

- 1. Bidder should take into account any corrigendum published on the tender/auction document before submitting their Bids.
- 2. Please go through the tender advertisement and the tender/auction document carefully to understand the documents required to be submitted as part of the bid please note the number of covers in which the bid documents have to be submitted. The number of documents including the names and content of each of the document that need to be submitted any deviations from these may lead to rejection of the bid.
- 3. Bidder in advance should get ready the bid documents to be submitted as indicated in the tender/auction document/schedule and generally, they can be in PDF/XLS/RAR/DWF/JPG formats bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned documents.
- 4. To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the Bidders.
