




1. The SA, ASI, Jodhpur Circle requires quotation from reputed well established and financially sound Contractors/Companies/Firms/Agencies for the work **"REPAIRS AND DEVELOPMENT WORK OF DEVI TEMPLE COMPLE (LOCALLY KNOWN CHAMUNDA DEVI) AT FORT MANDORE, DISTT. JODHPUR-SUPPLY OF MATERIALS"**
2. **The rates quoted by the contractor shall be valid for 365 days from the date of acceptance of tender. The materials will be supplied within 45 days from the date of issue of each supply order or as per requirement at site.**
3. The interested Contractors/Companies/Firms/Agencies may deposit/submit the tender documents complete in all respects along with the Earnest Money Deposit (EMD) in the form of Demand Draft/Pay order drawn in the favor of Superintending Archaeologist, Archaeological Survey of India, Jodhpur Circle and the same may be delivered through any of the delivery mode (Speed Post/Courier etc) or drop it in the tender box kept at office of SA, ASI, Jodhpur Circle, Jodhpur.



REGISTRATION

- 1) Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL: <https://eprocure.gov.in/eprocure/app>) by clicking on the link "**Online Bidder Enrolment**" on the CPP Portal which is free of charge.
- 2) As part of the enrolment process, the Bidders will be required to choose a unique username and assign a password for their accounts.
- 3) Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 4) Upon enrolment, the Bidders will be required to register their valid Digital Signature Certificate (Class II or. Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify I NCode I EMudhra etc.), with their profile.
